## Rules and Regulations

*The following rules shall govern the tournament. The tournament director and committee shall be sole interpreters of the rules and their decisions shall be final.*

- 1.) Any person 16 years or older is eligible to enter the tournament provided they are represented by a ticket.** Youngsters under the age of 16 may enter provided they are accompanied by a parent or guardian of legal age who is also entered in the tournament and with whom the youngster must fish with during the event. You must be 18 years of age to actually purchase a ticket. Children under the age of 16 do not have to be represented by a ticket.
- 2.) Anyone fishing MUST be preregistered by 11:59 p.m., April 23, 2010.** You must be preregistered to win any of the fishing prizes.
- 3.) Tournament Weigh In Headquarters:** The Voyageur, 525 Riverside Ave. St. Clair, MI
- 4.) Tournament Boundaries:** Lower Lake Huron, all of St. Clair River and its three channels. Fish from boat only.
- 5.) Tournament Timetable:** April 24, 2010  
Fishing Contest, 6:00 a.m. to 1:00 p.m.  
Weigh In, 1:00 p.m. to 3:00 p.m.  
(Must be in weigh in line by 3:00 p.m.)
- 6.) Boat Safety:** All boats participating in the Tournament will be required to pass United States Coast Guard requirements for the Great Lakes or Michigan Dept. of Natural Resources boat safety requirements. The Voyageur and the Blue Water Sportfishing Association will not be responsible for any injury or damage resulting to any participants in the tournament. All participants must sign the attached Official Registration Form and Consent which releases The Voyageur and the Blue Water Sportfishing Association from any liability.

**Please Note: Lake Trout will not be included in this year's tournament.**

**7.) Registration Forms:** By signing a registration form, the captain or individual offers implied consent to the committee for one or more of the following:

- A.** Disclosure of fishing conditions and manner in which a fish was taken and at what time.
- B.** Submission to a polygraph test issued by a polygraph examiner.
- C.** All participants must sign the attached Official Registration and Consent Form which releases The Voyageur and the Blue Water Sportfishing Association from any liability.

**8.) Fishing Regulation:** All entrants must obey 2010 Michigan and or Canadian fishing regulations, and have all proper licenses, and purchased a raffle ticket. All fish to be weighed may be subjected to an inspection by the Tournament Committee in which case the decision will be final as to the enterable condition of the fish. All eligible fish to be weighed in must be at least 18 inches long. Your team may weigh in up to a 4 person DNR limit = (20 fish maximum).

**9.) Ties:** Ties will be broken by the length of the fish.

**10.) Protest:** Any contestant wishing to officially protest the conduct or score of another entrant must do so in writing and pay a \$100.00 protest fee to the Tournament Committee within 15 minutes of the concluded weigh in. The Tournament Committee shall be the sole judge in determining if an infraction of the rules or spirit of the tournament has taken place and shall take whatever action it deems appropriate. All decision of the committee will be final!
