- 5. No snagged or foul hooked fish should be entered.
- 6. All information MUST be completed on registration form printed herein or entry will be voided.
- 7. Only members of the Association, prior to catching fish, are eligible.
- 8. Violators of the rules, or state regulations, will be disqualified from the
- 9. In the event of a tie, winner will be determined by length of fish.
- 10. Be sure to enter the age of the person entering the contest, so it can be placed in the proper division.
- 11. All entries MUST be mailed to the club address or presented directly to the big fish chairman.
